## MISSION

• The mission of the Custodes Libertatis Memorial Foundation is to provide educational scholarship tuition grants for a post-secondary degree from an accredited two or four-year college, university, technical, or trade school to the children of graduates of the United States Naval Academy who have lost their lives in combat against the enemies of the United States of America, as a result of Military Training, in the line of United States Department of Defense Duty, or as a direct result of their service in the United States Intelligence Community, Law Enforcement Agency, Emergency Medical Services or as a First Responder, in the period following September 11th, 2001. The Foundation is an American tax-exempt 501(c)(3) nonprofit organization founded to provide these grants to the children.

## BACKGROUND

- Three USNA Class of 2006 graduates began to establish the Foundation on Memorial Day of 2016
- Consultations conducted with Naval Academy Foundation representatives, Class of 2006 officers, Class of 1963 Foundation officers, USNA and USMA alumni, philanthropists, former government officials, corporate executives, nonprofit founders
- Charter drafted and filed in August 2016 in State of Delaware
- IRS application for 501(c)(3) status filed in September of 2016 and granted in November of 2016
- Investment Policy Statement drafted November of 2016 with Discretionary Portfolio Mandate adopted
- Formal accounting system with quarterly financial statements
- Foundation is insured by nationally recognized carrier

#### BACKGROUND

- Foundation received first donation in December 2016
- Scholarship Vetting Policy is utilized for verification of eligibility
- Civilians and U.S. Navy and U.S. Marine Corps veterans operate as volunteers, including: fundraising, website, scholarship advocacy/vetting, liaison to "adjacent units" and non-profits
- Board meets quarterly; addition of directors Maryellen Reilly (Q3 2017), Jared Sprunk (Q3 2018), Steve Hudock (Q1 2020)

#### **OPERATIONS**

- Approximately 44 children identified to date; Foundation continuously tracks new casualties and researches past casualties while interacting with class officers and families and reviewing news media
- First scholarship awarded in February 2018 to son of 1987 graduate
- Scholarships and Students:

• 2020: \$21,200 2019: \$44,909 2018: \$ 27,509

• 2020: 4 2019: 5 2018: 4

• Donations raised:

• \$2 million is the target to create a perpetual fund which awards ~\$50,000, inflation adjusted, for ~5 beneficiaries annually.

## STANDARDS AND GOALS

- Standard: The Corporate Charter prohibits compensation or benefits to any member, director, representative, or volunteer
  - The donations we collect fund scholarships for the children of our fallen alumni who have made the ultimate sacrifice in the line of duty
- Goal: Keep annual Operating Expenses below 10% in order to maximize the number and value of scholarships to eligible recipients.
  - Typical operating expenses: 1) tax preparation by outside CPA; 2) insurance; 3) credit card, banking and transactional fees associated with donations.
  - All other expenses carried by founders or contributed pro bono.
- Transparent financials: our financials and tax returns are available upon request and online. Nationally recognized nonprofit specialist CPA firm reviews and prepares tax returns.
  - CPA currently preparing analysis for elevation to 'Public Charity' classification
